



Community Tent

The Easton Farmers' Market Community Tent is designed to showcase area non-profit organizations (501c3) that contribute to the health and well-being of the Easton community. The purpose of the community tent is to promote the organization and its community activities. While tickets to approved special events may be sold at the community tent, it is NOT intended to be a venue for selling products of any kind. Priority will be given to those organizations whose missions promote healthy living, the health and welfare of families and children or environmental initiatives. EFM receives a large volume of requests for the community tent and regrettably cannot accommodate all requests.

Rules for the Community Tent

Tent and 1 6ft Table are required. These items are available from EFM for a fee of \$20 and \$10, respectively. Alternatively, groups may provide their own tent and table.

Community Tent must be reserved at least 2 weeks in advance of the selected market day. Applications are available at www.eastonfarmersmarket.com and scheduling begins March 15, prior to the opening of Market season.

Electricity may or may not be available on any given date. If you require electricity please specify.

NO product may be SOLD from the community tent. This includes raffle tickets. As stated above, tickets to approved special events may be sold. Donation jars are permitted FREE Prize Drawings are NOT permitted.

No unsupervised children under age 16

No Music may be played from the community tent.

Organization must post adequate and appropriate signage and/or banners that clearly identify their group. Groups arriving without proper signage will not be permitted to set-up.

A table covering must be used and groups are encouraged to display materials in a tasteful, creative, eye-catching manner. Activities for children are strongly encouraged.
(Priority will be given to organizations offering an interactive experience for market shoppers.)

Organization must abide by EFM vendor rules and be set-up promptly by 9am and remain at the market until 1pm or close of event. NO EXCEPTIONS.

Multiple weeks may be applied for, but consecutive weeks will not be guaranteed.
